The British actually introduced the language to the Americas when they reached these lands by sea between the 16th and 17th centuries. At that time, spelling had not yet been standardised. It took the writing of the first dictionaries to set in stone how these words appeared. In the UK, the dictionary was compiled by London-based scholars. Meanwhile, in the United States, the lexicographer was a man named Noah Webster. Allegedly, he changed how the words were spelled to make the American version different from the British as a way of

showing cultural independence from its mother country. Throughout time, the people of America had different goals and tasks than the people of England, their history developed differently, and they lived in a different natural world, which could not but affect the language, so it absorbed many changes. This is how American English came about, along with British English and other variants of its development.

MAIN BODY: As we know there are different varieties of English: American English, British English, Australian English, Canadian English, New Zealand English. Hybrid languages: Pidgin English, Beachlamar, Kroatian English. Pidgin English was used in New Zealand and Australia in operations with the Far Eastern population. Beachlamar is slang used in the Polynesian islands that include French and Spanish words in addition to the English vocabulary. Kroatian English is spoken in West Africa. It is a mixed language based on English with a mixture of Portuguese vocabulary. But English is closest to the English: Australian version, New Zealand version. Due to their geographical isolation, Australia and New Zealand have not been strongly influenced by other languages and cultures. Such a rethinking was due to the fact that at that time in the colonies any store, by virtue of necessity, was also a warehouse of goods. Hence the phrase keeps the store arose. A special group consists of words, the meaning of which has undergone a complete rethinking. This process can be traced, for example, in the English noun corn, which in England means any crops. In America, the word corn came to mean corn, i.e. exactly the crop that the first settlers had to cultivate. One of the sources of filling the vocabulary during this period was borrowings from other languages, primarily from the languages of the Indian tribes that lived in North America. In contrast, collective nouns can be either singular or plural in British English, although the plural form is most often used (e.g. The band are playing). The British are also more likely to use formal speech, such as 'shall', whereas Americans favour the more informal 'will' or 'should'. Americans, however, continue to use 'gotten' as the past participle of 'get', which the British have long since dropped in favour of 'got'. 'Needn't', which is commonly used in British English, is rarely, if at all used in American English. In its place is 'don't need to'. In British English, 'at' is the preposition in relation to time and place. However, in American English, 'on' is used instead of the former and 'in' for the latter.

CONCLUSION: In conclusion, although there may be some differences between British and American English, the main thing is that the two have more similarities. Accidentally using one instead of the other does not lead to miscommunication. Americans and Brits can usually communicate with each other without much difficulty, so don't be too hard on yourself if you can't memorize the nuances of both languages.
