From this history to our time, the program of accounting in the Treasury was clearly established under Amir Temur. This is very much like the budget policy of the state in the current time.

Then the teacher Alisher Navoi connects the subject to the science of literature through his thought.

Our great ancestor Alisher Navoi advised ordinary people not to refuse to pay taxes . such an act is" tantamount to abusing one's partner". It is natural that the thoughts of Alisher Navoi about the tax , about the payment of hiroj, will help to find out the historical basis of knowledge about the tax system of our independent state .

In Article 51 of the Constitution of the Republic of Uzbekistan, citizens are obliged to pay taxes and local levies established by law .Through these words, some economic terms, in which the reader associates with the science of law, are related precisely to the science of law. While the topic mainly talks about income taxes levied on individuals and legal entities, we will first give a definition to both.

An individual is a citizen of the Republic of Uzbekistan, foreign citizens and stateless persons.

Let's consider how much tax the employee receives from this income the state. The minimum wage was 96,105 in January 2014. We tell him that you need to catch 7.5% for earnings from 1 to 6 times using the table, which means that 5×96105×7,5%+5×96105×16%+(1000000-961050)+22%=36039,4+76884+8569=121492,4 it turns out that the sum must pay income tax. The student can be taught to catch income tax by knowing the minimum wage when performing this action on a mathematical basis.
